

POLICY SCREENING FORM

Background

Under Section 75 of the Northern Ireland Act 1998, the College is required to have due regard to the need to promote equality of opportunity:

Scoping the Policy

Title of Policy: Tackling Anti-social Behaviour (ASB) Model Policy (v5) – May 2025

Policy Aim: The aim of this policy is to provide the Association's Officers (employees) with clarity and guidance regarding the terms specified within Newington HA's Good Neighbour Agreement and a Statement of Policy on dealing with ASB.

Policy Ref: 6.1.7.2

Brief Description: Via this policy, the Association provides clarity on the requirements of tenants to adhere to the terms specified with our Good Neighbour Agreement.

The Statement of Policy on Anti-Social Behaviour (ASB) clarifies:

- What is and what isn't deemed as incidents of ASB.
- Our approach to tackling ASB.
- The preventative measures we have in place.
- Our statutory obligations, specific legislation, etc.
- Arrangements in place for supporting complaints witnesses and perpetrators.
- Use of mediation.
- Multi-agency partnership working approach.
- Our requirements with respect to GDPR, data protection and confidentiality.
- How we will train, protect and support staff.

Who defines or defined the policy?

Newington's Board of Management and Communities Director is responsible for defining, approving and amending this document, which must reflect current legal and legislative guidance or requirements.

All employees of the Association must abide by these requirements.

The Board, Chief Executive Officer and Director of Communities will mainly define this policy.

Who implements the policy?

Newington Housing Association employees will implement this policy.
